TEAM COMMITMENT AND RESPONSIBILITIES

We, the undersigned, wish to enter the above championships and we have read and understood the Guidance Notes (June 2017) which accompanied this form and also Annex A of the ECA Constitution which also accompanied this form.

In particular we agree that:

- 1 If we withdraw after the closing date for entries we will forfeit the entry monies above.
- 2 If we fail to attend the event we shall be liable for any proportion of the ice fees which can be attributed to our absence.
- 3 We are all **FULL** members of a member club of the English Curling Association. (This may need to be confirmed by your club secretary before you can play).
- 4 We are all eligible to represent England as specified in Section 7.2 of the ECA Constitution

INTERNATIONAL REPRESENTATION

We, the undersigned, understand:-

- 1 The winning team of an English Championship will be expected to represent England in the corresponding International Championship for which the entry has been made and in other Championships where participation is dependent upon qualification from the initial competition, except in the circumstances outlined below.
- 2 For Championships involving teams of 4 /5, if one member of the winning team is unable to participate in the respective International Championship, a substitute may be called upon subject to the approval of the ECA Council. If two or more members of the winning team are unable to participate, the ECA Council will have the discretion to replace the whole team with the runners-up from the relevant English Championship or, if the runners-up are unable to participate, with any other eligible team.
- 3 Any team which represents England in an International Championships must be accompanied by a non-playing / coaching adult if it includes a player who is under 17 years of age at the time of the competition. If this condition cannot be met then the ECA reserves the right to either replace the affected player or replace the whole team with another team.
